Subject: Deputation of Central Excise Superintendents / Inspectors to C.S.I. Airport, Mumbai – reg.

Please refer to this office earlier letter of even No./2145-62 dated 10.02.2016 under which options were invited from the willing & eligible officers in the grade of Superintendent & Inspector for 05 posts of Superintendent and 07 posts of Inspector as Air Customs Superintendent (ACS) and Air Customs Officer (ACO) to be filled up on deputation basis to C.S.I. Airport in pursuance of letter F.No. S/5-110/2011-ESTT/P&E(P) dated 22.01.2016 received from Additional Commissioner of Customs (G), P&E/PREV, Office of the Principal Commissioner of Customs (General), Mumbai.

In this regard, options are once again invited from the willing & eligible officers in the grade of Superintendent & Inspector of Central Excise.

It is requested to forward the options of Superintendent & Inspector who are willing and eligible for posting at the subject Airport by 30.06.2016.

It is also requested to furnish the following information in absence of which candidature of the optee officers will not be considered:-

1. Bio-data, which must indicate the date of birth and date of appointment to the present cadre of the officer concerned along with the history of posting.
2. Last 5 (five) years A.C.R. gradation synopsis and not the Xerox copy of the C.C.R. Dossier.
3. Latest Seniority List No.
4. Vigilance Clearance Certificate and Integrity Certificate duly signed by the Head of the Deptt.
5. No option will be considered unless it is received through proper channel.
6. Forwarding authorities while forwarding the options to this office is to furnish details in the enclosed format (Annexure A).

SYNOPSIS OF BIODATA OF OFFICERS

1. The officers posted at Airport will be eligible to draw pay and allowances at the same rates admissible to them from time to time.
2. They shall be considered as on deputation to the Airport, but no deputation allowance is admissible to them.
3. Normally, the period of deputation at the Airport is two years and it can be extended by one more year. However, an officer at the Airport can be reverted before completion of two years without assigning any reason.
4. The Officers posted at the Airport will have to make their own arrangement for residential accommodations.
5. The Officers will also be entitled to draw uniform and diet allowance as admissible under the rules.
6. In the event of their promotion to the higher grade, the Officers will be liable to be reverted back to their parent Commissionerate and posted any where as may be ordered by the competent authority in this regard.
7. The following Officers are not eligible for consideration for posting at C.S.I. Airport, Mumbai.
 - (f) Officers who have not completed two years of cooling off period after completing their tenure in DGRI/ DGCEI/ NCB/ ED/ EIB and or any other International Airport as on 30.06.2016.
 - (g) Officers due for superannuation within the next 2 years.
 - (h) Officers transferred out of Airport/ Sensitive places on administrative grounds.
 - (i) Officers having Vigilance/ Non-vigilance cases pending against them.
 - (j) Officers against whom penalty is operative.
