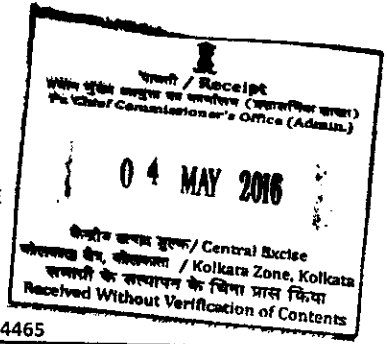

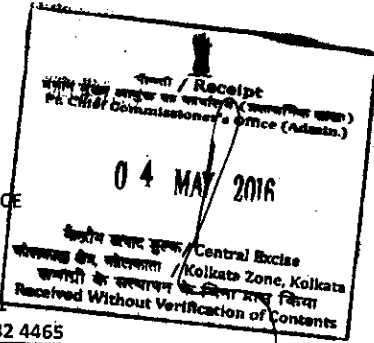

The selected officers, on appointment, will be entitled for Special Pay of the basic pay as admissible and they have to make their own arrangements for residential accommodation. Normally, the deputation is for a period of five (5) years, which can be extendable by another two years, subject to willingness of the officers, his/her performance, concurrence of his/ her parent Commissionerates and approval of the Competent Authority.
- Further, as per Para IV of Ministry's F. No. A35017/28/92-AD.IIIB dated 30.06.1994, officers posted in certain charges/ organisations/ assignments/ are required to complete the 'Cooling Off' period of not less than two years before posting in Directorate of Revenue Intelligence. However, the concerned Chief Commissioner of Customs/ Central Excise has been given the power to relax the "Cooling Off" period.
