Subject: Deputation of Superintendents of Central Excise as Air Customs Superintendent (ACS) at N.S.C.B.I. Airport, Kolkata – reg.

Applications through proper channel with the approval of jurisdictional Commissioner are invited from Superintendents of Central Excise for one (01) post of Air Customs Superintendent (ACS) at Netaji Subhash Chandra Bose International (NSCBI), Airport, Kolkata, on deputation basis.

The applications should accompany following informations & documents:-

1. Bio-data indicating the date of birth and date of appointment to the present cadre of the officer concerned along with the history of posting (to be certified by the Competent Authority).
2. ACR / APAR gradation synopses for the last five (05) years are to be furnished. The photocopies of ACR/APAR will not be accepted.
3. Serial Number of the officer in the Latest Seniority List.
4. Vigilance Clearance Certificate and Integrity Certificate duly signed by the Head of the Department.
5. Forwarding authorities while forwarding the options to this office are to furnish details in the enclosed format (Annexure A).

The following conditions may also be taken into account while forwarding the Applications:-

1. If selected, the officers posted at Airport will be governed by the terms & conditions issued by the concerned customs authorities.
2. They shall be considered as on deputation to the Airport, but no deputation allowance is admissible to them.
3. Normally, the period of deputation at the Airport is two years. However, an officer at the Airport can be reverted before completion of two years without assigning any reason.
4. The Officers posted at the Airport will have to make their own arrangement for residential accommodations.
5. The Officers will also be entitled to draw uniform and diet allowance as admissible under the rules.
6. In the event of their promotion to the higher grade, the officers will be liable to be reverted back to their parent Commissionerate and posted anywhere as may be ordered by the competent authority in this regard.
7. The following officers are not eligible for consideration for posting at NSCBI Airport, Kolkata:-
 - (a) Officers who have not completed two years of cooling off period on their return from DGRI / DGCEI / NCB / ED / CEIB / AIRPORTS / ANTI EVASION (DIVN. & HQRS.) / EXPORT REFUND as on 31.03.2016.
 - (b) Officers due for superannuation within the next 2 years.
 - (c) Officers transferred out of Airport/ Sensitive places on administrative grounds.
 - (d) Officers having Vigilance/ Non-vigilance cases pending against them.
 - (e) Officers against whom penalty is operative.

It may please be noted that the officers who have already submitted their applications in response to this office letter C.No. II(13)1-ET/CCO/CE/KOL/2015/23422-38 dated 29.06.2015 need to apply afresh if they are willing.

The applications complete in all respect should reach this Office latest by 04.04.2016.
