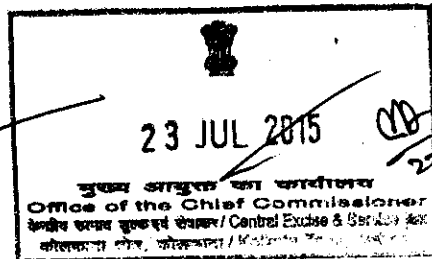

Sub: Request for posting of officers at all levels in CESTAT, Kolkata. On loan basis-reg.

Office of the Commissioner (A.R) is facing acute shortage of officers right from the level of TA to JC/ADC. At present 8626 cases involving revenue Rs.3848 corers are pending with the Tribunal. During Nov-Dec, 2014 Tribunal had initiated a drive for disposing of stay matters. Further with the enactment of section 35F in Central Excise Act 1944 and section 129E in Customs Act 1962, there is no need to file stay applications with the effect from 6<sup>th</sup> Aug, 2014. As a result, larger number of cases are coming up for hearing for regular hearing.

At present only three Assistant Commissioners, three Superintendents and one Appraiser are working in this office as Authorised Representative. By the end of October, 2015 there will be only five A.Rs consisting of two recently promoted Assistant Commissioners and three Superintendents. This is an alarming scenario as even the existing officers are unable to cope up with the pressure of work.

In this context it is requested that two more Assistant Commissioners, two Superintendents, two Appraisers, three Inspectors, and three Tax Assistants may be posted to this office on loan basis. There are precedent of posting officers from Central Excise, Service Tax & Customs to CESTAT on loan basis. The officers may preferably be those who have sufficient residual service and an aptitude for working in this office.
