




In compliance to the instructions contained in Board's letter dated 14.01.2015 issued under F.No.22011/12/2012-Ad.II, the Chief Commissioner of Central Excise, Kolkata Zone is pleased to notify "Link Officer arrangement at the level of Additional / Joint Commissioner in Kolkata Central Excise Zone" in the manner as specified in the "Annexure-A".

In the context of this, it is clarified that the "1st Link Officer" shall assume the charge of the Additional / Joint Commissioner, in respect of the official who is holding the regular charge, till the time the regular incumbent is absent from duty by reason of leave, tour to outstation or otherwise and shall continue to hold the charge until the regular incumbent resumes duty or any other order is issued in this regard relieving the "1st Link Officer". In case, the "1st Link Officer" is unavailable for such aforesaid reasons, the "2nd Link Officer" will assume the charge of the regular incumbent and this arrangement will go on for all the successive "Link Officers" mentioned in the said "Annexure".

The said "Link Officer Arrangement in the level of Additional / Joint Commissioner" comes into force with immediate effect.
